Policy 1350 Community Participation at BOE Meetings

DISCUSSION	Policy Committee Chairperson Jeannette Nichols opened the floor for a discussion regarding the Call to the Audience portions of the Board of Education's Regular Meetings. A discussion was held on whether to uphold two periods of twenty-one minutes each or to revert to the old policy which allowed only one thirty minute period. The committee decided that the policy would remain the same with two twenty-one minute periods. The policy will now give the Chairman the discretion to consolidate the two periods into one if time permits.

Policy 7552 Field Trip (International Field Trip Procedure)

DISCUSSION	Policy Committee Chairperson Jeannette Nichols and the committee members reviewed the revised changes with the group and offered the following suggestions: to include the district website when providing information regarding field trips, add links whenever possible, non-New Hanover County Schools field trips will be referred to as sanctioned field trips, additional language must be added that states that staff and students may not use NHCS modes of communication, school grounds or advertise on school system property/website for non-NHCS sanction field trips. In addition, students and staff may not organize, announce or promote non-NHCS sanction field trips during the school day.
