DISCUSSION	Chair Lisa Estep called the meeting to ordered, welcomed the group, and thanked the group for attending. Mrs. Estep welcomed to the committee newly appointed- NHCS Title IX Director - Jarelle Lewis. Mrs. Estep gave an overview of Mr. Lewis' background and experience. Mr. Lewis thanked everyone for the work that has been done by the committee and shared he was happy to be apart of NHCS and that he was ready to hit the ground running. NHCS General Counsel Wayne Bullard, along with Mr. Bullard gave an overview of the drafts of the Title IX policies. The goal for these policies is to meet Title IX standards. The draft policies were put before the committee for discussion. Mr. Bullard and Mr. Lewis shared that OCR gave guidance what they like to see in policies, and the guidance works for everyone; protects everyone's rights – easily understandable. Superintendent Dr. Tim Markley shared that he would like to see the proposed policies adopted by January, with them being taken to the Policy Committee by October/November. Student Support Services Director Kristin Jackson gave an update on training. All Middle School Health Teachers have been trained on Shifting Boundaries. Training for the Darkness to Light program will occur on September 19 th for Coaches and October 3 rd for Principals. The representatives from Coastal Horizons gave an update on additional trainings that addresses cultural norms and give tools to safely step in and intervene. Mrs. Jackson shared videos that had been created by NHHS students. Dr. Markley reiterated that policy creation was rolling along. He shared that future meeting would be coordinated by Mr. Lewis.
